

## EIFL-OA update

### EIFL cooperates with CHAIN-REDS Knowledge Base

EIFL and [CHAIN-REDS](#) signed a Memorandum of Understanding to promote the adoption of consolidated standards in the e-Infrastructures for Research and Education, with the ultimate aim of widening the opportunities of data sharing across different e-Infrastructures in Asia, Africa, Europe and Latin America.

CHAIN-REDS is a FP7 project co-funded by the European Commission (DG CONNECT) aiming at promoting and supporting technological and scientific collaboration across different e-Infrastructures established and operated in various continents, in order to define a path towards a global e-Infrastructure ecosystem that will allow Virtual Research Communities, research groups and even single researchers to access and efficiently use worldwide distributed resources (i.e. computing, storage, data, services, tools, applications).



EIFL will encourage integration of open access repositories in EIFL partner countries into the [CHAIN-REDS Knowledge Base](#), using the OAI-PMH standard and the Dublin Core metadata schema.

CHAIN-REDS is also building a semantic search service on top of publication and data repositories – the [CHAIN-REDS Semantic Search Engine](#) that will search across the thousands of semantically enriched open access document and data repositories included in the CHAIN Knowledge Base.

In June 2013 in the context of the [collaboration](#) between CHAIN-REDS and [LA Referencia](#) on data infrastructures, all open access repositories from Argentina, Brazil, Chile, Colombia, Ecuador, El Salvador, Mexico, Peru and Venezuela that are included in LA Referencia have been harvested using an [OAI-PMH](#) standard end-point and integrated in the CHAIN-REDS Knowledge Base. In order to browse them you can follow [this link](#) and write LA Referencia in the Search window. The documents of LA Referencia will also be soon searchable by the CHAIN-REDS Semantic Search Engine. This will make Latin American researchers and their scientific products more visible and semantically correlated with those of the other regions of the world.

We hope to achieve similar results in Asia, Africa and Europe.

## The first national open access conference in Uganda



The [Consortium of Uganda University Libraries \(CUUL\)](#) in partnership with EIFL and the [Regional Universities Forum for Capacity Building in Agriculture \(RUFORUM\)](#) organised the first national conference on “Open access (OA), knowledge sharing and sustainable scholarly communication in Uganda” on May 21, 2013 at the Silver Springs Hotel, Kampala.

The objective of the conference was to bring together stakeholders from academic and research institutions to discuss and layout strategies for OA adoption, to address the challenges of maximizing the visibility of research output and improving the quality, impact and influence of research; publishing OA journals and books and developing OA repositories; promoting the adoption of OA policies.



87 research administrators (Research Directors, Deans and Head of Departments), lectures, academic journal editors and publishers, librarians and information managers, journalists and reporters attended the event.

Dr. J. C. Musingo, Minister of State-Higher Education, was a chief guest speaker who opened the conference. Below are some highlights from his inspiring speech:

*"No one can truly be an academician unless he/she adds value to the bank of existing knowledge through research."*

*"A lot of research has been undertaken over the years and many seeming breakthroughs arrived at, however these have not been disseminated and subsequently have not added value to the lives of Ugandans.*

*In the same vein, one of the biggest costs of higher education; especially at higher degree levels has been that of purchasing and/or subscribing to journals. This cost has curtailed access and quality of higher education.*

*I wish therefore to congratulate CUUL members that have been involved in advocacy for OA at their respective institutions and also for those institutions that are taking steps to adopt it.*

*Government welcomes these initiatives and will work with all stakeholders to make open education a high priority.*

*I wish to call upon the National Council for Higher Education [supporting research at public Universities]*

and Makerere University Library to put in place a system that ensures that all public funded research becomes part of open education resources.

Scholars have already proved this as the way to go and the Ugandan academia cannot afford to be left behind at all.

Government through the National Information and Technology Authority-NITA (U) is working hard to ensure that ICT infrastructure is in place so that the costs involved with it can come down so that OA can be more approachable.

I call upon all member institutions to consider the payment of the authors' fees so as to enable them publish in OA journals, advocate and demystify OA and also to consider OA publications in promotion and tenure evaluation."

During the collaboration and way forward discussion participants discussed approaches to raise visibility and accessibility of research outputs in Uganda that combine awareness raising, policy work and practical training to promote and set up OA journals and OA repositories at institutions of higher learning.

Four institutional follow-up visits and OA awareness raising workshops took place on May 22-23 at Uganda Martyrs University, The Makerere University Business School, Uganda Christian University and Uganda Management Institute.

This was the first national event in Uganda within "OA: knowledge sharing and sustainable scholarly communication in Kenya, Tanzania and Uganda" – a new EIFL regional project funded by Spider, the Swedish Program for ICT in Developing Regions DSV, Department of Computer and System Sciences, Stockholm University. This project will run until June 2014 and is implemented in partnership with EIFL partner consortia: Kenya Library & Information Services Consortium (KLISC), Consortium for Tanzania Universities and Research Libraries (COTUL) and CUUL.

### Mykolas Romeris University adopts an open access policy

Mykolas Romeris University, Lithuania, has been actively involved in the open access movement. In February-March 2013 they conducted workshops on innovative teaching, open access initiatives, European Commission's open access policy and recommendations regarding open access, OpenAIRE project, open access publishing, national open access repository eLABa, research evaluation indicators and altmetrics. And as a result of these workshops and other activities University's research and educational publications are open access.



"Mykolas Romeris University supports open access thereby realizing the third function of the University (in addition to teaching and research) – social responsibility to the society. Open access promotes international co-operation, researchers networking, new cross-disciplinary research, innovation, development, sharing of information and promotion of science", said Nijolė Liatukienė, Mykolas Romeris University Library Vice director.

Mykolas Romeris University open access policy and open access institutional repository were adopted and launched in June 2013 to ensure open access to the scientific production of the University. The repository will contain scientific publications, books, conference papers, student final papers (graduate and undergraduate thesis) and other scientific output produced by Mykolas Romeris University staff. The University also provides open access to all their publications: e-books (currently the collection holds over 130 titles) and scholarly journals (currently nine titles are available [here](#)).

### The winners of EIFL OA advocacy call for proposals

Following the successes of 2011-2012 grant competitions (see [EIFL-OA case studies](#)), the EIFL-OA programme invited new proposals for national or institutional open access (OA) advocacy campaigns to reach out to research communities. We received over 30 proposals from 23 countries and we thank everyone who sent an application!



Ten projects in Africa, Asia, and Europe have been chosen to receive funding: three projects in Africa (in Ethiopia, Lesotho and Senegal), a project in Asia (in China) and six projects in Europe (Armenia, Belarus, Estonia, Moldova, Poland and Serbia). The projects will be implemented from June 2013 to March 2014. At the end of the projects, case studies will be written illustrating activities, advocacy strategies, successes and lessons learnt so that libraries everywhere can benefit. Congratulations to the grantees, and we look forward to successful projects!

#### National OA advocacy campaigns

**Country:** Armenia

**Grantee:** [Electronic Library Consortium of Armenia \(ELCA\)](#)

**Project title:** **Promoting OA in Armenian research and education communities**

**Summary:** The project is aimed at researchers and research organizations, MS and PhD students, as well as journal publishers. Main activities include workshops on OA in research centers and major universities; developing information materials about OA and launching a web-portal about OA. As a result of the project more students and researchers will be involved in the OA movement, publish more articles in OA journals and more Armenian journals will be published under Creative Commons licenses.

**Country:** Belarus

**Grantee:** Central Information and Analytical Center at the Ministry of Education of Belarus

**Project title:** **Promotion of OA for scholarly communication in Belarus on the basis of OJS platform**

**Summary:** The main objective of the project is to promote OA publishing in the country using a [national Open Journals Systems \(OJS\) platform](#). Localized OJS version, training materials, documentation, guidelines for publishers, journal editors, researchers, and librarians will be developed and advocacy materials will be disseminated. Workshops, training sessions and webinars for journal editors and publishers will be conducted.

**Country:** China

**Grantee:** [National Science Library, Chinese Academy of Sciences](#)

**Project title:** **2013 China OA Week**

**Summary:** The project will focus on developing and sharing good practices of OA in China, including open institutional repositories development and services, OA policies implementation, and OA publishing support. The goal is to push forward a national OA agenda and to make a bridge for the international collaboration and communication. The target groups are post-graduate students and researchers, librarians, research managers and national policy makers, editors of STM journals. Expected results of this conference are to improve the awareness of OA and to clarify some misunderstanding of OA; to promote OA practices and to encourage more OA projects.

**Country:** Estonia

**Grantee:** University of Tartu (UT) Library

**Project title:** **Encouragement and Practice of OA among Academics**

**Summary:** The goal of the project is to raise researchers', funders' and publishers' awareness of OA. Since 2012 the Estonian Research Council requires making research articles, produced from publicly funded research, available for everyone. Nevertheless, a clear national OA policy has not been developed yet. Raising discussions on the importance of having a national OA policy is one of the main project aims. The second aim is to raise awareness on open research data and to launch an open research data collection at UT OA institutional repository. An international conference on OA to research results and open data will be organized during OA Week to discuss how universities and research funders should require OA to publicly funded research results/data. It will be followed by the Open Data Months (October-November) when researchers will be encouraged to share their research data. UT Library will also organize a seminar on OA practices. The Estonian Ministry of Education and Research is one of the project partners.

**Country:** Ethiopia

**Grantee:** Addis Ababa University Libraries

**Project title:** **Promoting OA publishing to Ethiopian journals**

**Summary:** The project objective is to improve the visibility of accessibility of Ethiopian journals by promoting OA publishing and implementing Open Journal Systems (OJS) - a FOSS journal management and publishing system, developed by the Public Knowledge Project. A series of meeting, workshop and training will be conducted with researchers and students, research administrators and policy makers, as well as university presses and society publishers so that to improve their awareness on OA publishing and skill on OJS. It is expected that at the end of the project more journals will use OJS and will be published in OA which in turn will improve the visibility and the accessibility of the journals internationally.

**Country:** Lesotho

**Grantee:** [Lesotho Library Consortium \(LELICO\)](#)

**Project title:** **Advancing faculty-driven OA policies and practices among academic faculties in Lesotho**

**Summary:** The aim of the project is to involve lecturers, students and librarians to formulate, adopt and implement faculty-based OA policies at the National University of Lesotho and Lesotho College of Education. Advocacy strategy includes setting up an OA advocacy committee, organizing a workshop and other training and promotional events, assisting three academic journals to be published in OA; forging cooperation between active student groups and librarians; awarding the researchers, lectures and students with the most deposits in the OA repository.

**Country:** Moldova

**Grantee:** The Library Association from Moldova (LAM)

**Project title: OA Conect+ within academia in the Republic of Moldova**

**Summary:** LAM in partnership with research and innovation institutions, Council of Rectors from Moldova, publishers of scholarly journals, researchers and students launches a national OA campaign to democratize access to scientific information, increase visibility of research output, enhance the research impact, and overcome the barriers of dissemination and access to knowledge. Core activities will focus on promoting OA journals and their registration in DOAJ; encouraging researchers to publish in OA and research institutions to set up OA institutional repositories; developing partnerships to promote OA in academia; advocacy initiatives for inclusion of OA within national strategies and legislation of the Republic of Moldova; adopting institutional OA policies; and training librarians on OA advocacy.

**Country:** Poland

**Grantee:** Fundacja Projekt: Polska

**Project title: Students for OA in Poland**

**Summary:** The goal of the project is to engage students into OA advocacy. A workshop and a promotional campaign will be organized focused on the student community (representatives of students councils, journalists from student media, student organizations working in the field of law and young researchers (PhD candidates)), which will help to build internal capacity of student organizations and connect them with OA advocates in Poland. Additionally, educational and informational materials targeted at students will be created (publications, posters, infographics, short videos). As a result, we expect the perspective and voice of students to become more visible in the debate on scholarly communication in Poland, and to voice more strongly students support for OA.

**Country:** Serbia

**Grantee:** National Library of Serbia - KoBSON

**Project title: DOISerbiaThesis - assigning DOI to PhD thesis defended at Serbian Universities**

**Summary:** The project has a goal to motivate young researchers who already finished their PhD studies to deposit their PhD thesis into OA institutional repositories (IRs). By assigning DOIs to PhD thesis researchers will quickly become aware of increased visibility provided by OA IRs. Expected results: populating OA IRs by creating a “culture of depositing” among young researchers who will see the benefits and keep depositing their future research output; all PhD thesis will be available in OA; DOISerbiaThesis will become a contributor to DART Europe portal; Serbian researchers will practice OA publishing.

**Institutional open access advocacy campaign**

**Country:** Senegal

**Grantee:** the University Cheikh Anta Diop de Dakar (UCAD)

**Project title: UCAD OA Repository**

**Summary:** The project is aimed at establishing an OA institutional repository at UCAD and drafting an OA policy for UCAD using the [Guide of good practices for university OA policies](#) and drawing its inspiration from the [University of Nairobi OA policy](#).

EIFL-OA programme will provide support to the advocacy work during implementation of the projects.

### EIFL looks forward to implementation of Marrakesh Treaty

EIFL welcomes the adoption on 27 June 2013 of a historic [WIPO Treaty to facilitate Access to Published Works by Visually Impaired Persons and Persons with Print Disabilities](#) (known as the Marrakesh Treaty). The aim of the treaty is to alleviate the “book famine” for print disabled people by creating an international legal framework to enable the cross-border sharing of accessible materials.



Fifty-one countries signed the Treaty in Marrakesh - the largest number of countries ever to sign a WIPO-administered treaty immediately upon adoption. [EIFL looks forward to the next important phase of the work](#) - implementation of the Treaty into national law - and will cooperate with the World Blind Union and others to encourage early ratification by all Member States.

### NGOs set record straight on EU LDC press release

On 11 June 2013, the WTO TRIPS Council took a decision to extend the waiver for Least Developed Countries (LDCs) for implementation of the Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) for a further eight years until 1 July 2021.



In its press release of the same date, the European Union (EU) welcomes the TRIPS Council Decision, but also includes statements considered by civil society NGOs to be inaccurate and unrepresentative of the outcomes of the discussions. ## Advocating for improved copyright laws for libraries

**Impressive first-time achievements of eight EIFL-IP funded projects in Africa, Asia and Europe**



Restrictive copyright laws create legal barriers to accessing resources for education, research and personal development. This can have significant consequences for libraries in developing and transition countries where the ability to produce and use knowledge is a major factor in development. We advocate for fair and balanced copyright laws that support libraries in maximizing access to knowledge in the public interest.

In April 2012, the EIFL-IP programme issued a [Call for Proposals for copyright law reform advocacy campaigns](#). Funding was granted to eight projects in Armenia, Estonia, Latvia, Mongolia, Poland, Senegal, Uganda, Uzbekistan. The duration of the grants was from three to ten months. The [case studies resulting from the projects](#) reveal impressive first-time achievements that will place libraries in a position of strength for the future including:

- ✓ a legal analysis of national copyright law undertaken from a library perspective - the basic building block for reform - that delivered concrete recommendations for improvements in several countries;
- ✓ librarians invited to participate for the first time in current national copyright consultations;
- ✓ the formation of a Library Copyright Committee, new coalitions or library partnerships;
- ✓ over 1,100 librarians and policy-makers received training in library copyright issues that led to a new engagement with policy-makers;
- ✓ national coverage on television, radio and in print gave libraries a visible and vocal presence as “thought-leaders”;
- ✓ the first library copyright resources translated and adapted for local law.

- [Maendeleo Foundation](#) piloted an ICT-based agricultural information service in five community libraries and inspired community members to contribute funds to support the service in future.
- [Rwenzori Information Centre \(RIC-NET\)](#), working through a community library, used smart phones and other ICT to help over 800 farmers combat plant pests and diseases.

## Two African libraries help improve school results

Two more libraries in Africa have shared results of projects funded by EIFL's Public Library Innovation Programme (EIFL-PLIP). Results from projects in Kenya and Uganda show how libraries are using information and communication technology (ICT) to help struggling schoolchildren improve their marks and pass crucial exams. [Busia Community Library in Kenya](#) demonstrated the effectiveness of tablet computers pre-loaded with content related to the school curriculum and educational games in helping struggling schoolchildren improve their school results, confidence and social skills.

[Volta Regional Library in Ghana's](#) mobile library service, using solar power, took fully-charged laptop computers to schools to provide hands-on computer classes for over 200 children.

## Public library service for farmers wins ERSTE Award

Public Library Radislav Nikčević in Jagodina, Serbia, has won a prestigious ERSTE Foundation Award for Social Integration 2013, for its AgroLib-Ja service which improves farmers' lives. The service was launched in 2010 with support from EIFL's Public Library Innovation Programme (EIFL-PLIP).

The 35 winners were announced on June 27 at a ceremony attended by over 700 representatives of business, civil society and the media, in Vienna (Austria), in the MuseumsQuartier. The awards celebrate and promote the work of organizations fighting for social integration of marginalized communities in Central and Eastern Europe.



The 35 winners were selected by an internal jury of experts in social integration from almost 2,000

applicants. The winner of the €40,000 (about US\$52,400) first prize was Little People Romania for the project 'I Am Not Afraid', which helps children to understand and cope with cancer. Second prize (€30,000 / US\$39,000) went to Slovene Philanthropy for their 'Social Integration of Migrants' project, which promotes human rights of migrant workers in Slovenia.

Public Library Radislav Nikčević's AgroLib-Ja service was one of 26 projects that each won honorary awards of €16,000 (US\$21,000).

AgroLib-Ja increases farmers' access to information by building farmers' computer and internet skills and by providing free internet access at five village libraries. The service includes an [agricultural web-portal](#) for farmers to access and share information, and an [online market](#), where farmers are advertising and selling their produce. The library also hosts agricultural events, where farmers meet experts from government and non-governmental agricultural agencies, and has increased its collection of books and journals on agriculture.

Before introduction of the service in 2010, many village libraries in central Serbia had fallen into disrepair, and farmers were struggling to access the information they needed to improve their farming. The AgroLib-Ja service has revitalized five village libraries and connected farmers to each other, to experts and the wider world.

AgroLib-Ja is the second PLIP-funded service to win an ERSTE Foundation Award for Social Integration. In 2011, [Public Library Braka Miladinovci](#) in Radovis, Macedonia, won €15,000 (US\$19,500) for the Creative Minds Create Job Opportunities project, which motivates unemployed people, especially women, to find employment.

## Two African libraries help improve community health


