#### **OSI Appoints President for eIFL.net Advisory Board**

OSI appointed Professor Derek Law as President of the eIFL.net Advisory Board. Derek is at present Librarian and Head of the Information Resources Directorate at the University of Strathclyde in Scotland, where he has most recently led the development of the Glasgow Digital Library within the Centre for Digital Library Research.

He has worked in a variety of senior posts in several academic libraries in the UK for some thirty years, but for the last decade has been particularly associated with the development of electronic libraries and services, notably developing the concept of the Distributed National Electronic Resource in the UK. He was one of the team of three who negotiated the first national site licence in the UK in 1991, managed the UK's first electronic journal initiative in 1997-98 and currently serves as a member of the national Content Committee in higher education. He has a strong international track record and is currently completing his sixth and final year as Treasurer of IFLA. He has also advised national governments or government commissions on a variety of electronic library initiatives in Canada, Denmark, Malawi and Greece, as well as the European Union. A frequent author and lecturer he has spoken at conferences in over thirty countries and has had papers translated into seven languages.

He was awarded the Barnard prize for contributions to Medical Informatics in 1993, Fellowship of the Royal Society of Edinburgh in 1999 and was awarded an honorary degree by the Sorbonne in 2000.

Derek Law commented on his new appointment saying that " I began my career as a serials librarian and recently have been heavily involved in developing electronic libraries. My work with IFLA has allowed me to develop personal and professional friendships with colleagues in many countries and to develop a passionate belief in the need to develop an equitable system of scholarly communication which allows true sharing and ready access to information on a global scale. That experience means that I relish the challenges which eIFL will offer in helping to deliver that vision of a community of equals. Librarians have an unsung but real passion for working together and I look forward to contributing to that."

#### eIFL workshop in South Africa

Johannesburg, 30 June - 04 July 2003

On 30 June to 4 July, eIFL ran a very lively workshop with the African coordinators which was held at the Rosebank hotel in Johannesburg. On the first day, presentations on connectivity solutions for the Education sector in Africa, marketing strategy for a national consortium, the South Africa Site Licencing Initiative were delivered by experts. The second day focused on collection analysis, management of e-resources and integration of electronic resources. The workshop witnessed considerable progress in terms of current and future strategy for consortium building. #### MALICO - Malawi library consortia is a pilot country for VSAT

Malawi is the leader in an eIFL connectivity project with VSATs to be installed at 4 MALICO sites - Mzuzu University, Bunda, Chanco/CLS and College of Medicine. The main reason for this investment is to allow improved access to electronic information, especially to scholarly publishing. It represents an investment in

MALICO and we will concentrate on this to ensure maximum result. For example, those whose bandwidth has improved could do the downloading of full text documents for the sites which are still struggling with dial-up connections.

## **LOCKSS Project**

eIFL is pleased to present LOCKSS (Lots of Copies Keep Stuff Safe) that developed software which enables institutions to locally collect, store, preserve, and archive authorized content thus safeguarding their community's access to that content. It is a tool for preservation of electronic journals. It was designed and is being implemented at Stanford University Libraries with funding from the National Science Foundation, Sun Microsystems, Inc and the <u>Andrew W. Mellon Foundation</u>.
