## **Minutes of the Board meeting**

The minutes of the second eIFL Advisory Board Meeting, which was held on 02-03 August 2003 in Berlin, are now available on our member's only section.

Very detailed discussions on Board elections as well as country membership took place during the meeting. Within couple of days, you will receive a document outlining nomination process for the elections which will take place at the General Assembly in October. Start thinking about the candidates.

### **News about the partnership with Goethe Institute**

The Goethe Institute is impressed with the eIFL approach to encourage affordable and sustainable access to electronic information by libraries in developing countries and wants to cooperate with eIFL to export the eIFL model to Latin America and the Middle East. The Goethe Institute representative will attend General Assembly as an observer.

### **Collaboration with similar initiatives**

During the summer, meetings were hold with INASP, Biomed Central and TIB, the German National Library of Science and Technology, on how to collaborate and how eIFL consortia could make the best use of the resources that are being offered by those intiatives. All of them have been invited to give presentations at the General Assembly.

#### eIFL.net at IFLA

Lots of visitors came to eIFL's stand that also served as a meeting point for those coordinators who were attending the conference.

We had a lot of interest from African and Latin American countries that are not presently members of eIFL. Preliminary discussion was held with Ross Shimmon, secretary general of IFLA, about formal cooperation between eIFL and IFLA in bringing sustainable access to electronic information to libraries in developing countries. It was useful and fun to have a stand and we are planning to do the same at the next IFLA conference in Buenos Aires in August 2004.
